**Call to Order:** Mayor Tarter called the meeting to order at 7:33 p.m.

**Roll Call:** Upon roll call, the following members were present: Mayor Tarter, Vice Mayor Connelly, Mr. Duncan, Ms. Hardi, Mr. Snyder, and Mr. Sze. Mr. Litkenhous was absent.

### **Resolutions and first readings of ordinances**

**(TO18-01)** ORDINANCE TO AMEND CHAPTER 48, ARTICLE IV, DIVISION 10, “B-2 CENTRAL BUSINESS DISTRICT”, OF THE CODE OF THE CITY OF FALLS CHURCH TO AMEND SEC. 48-486. “PRINCIPAL USES PERMITTED BY RIGHT” IN ORDER TO ALLOW ADDITIONAL USES AND TO EDIT LANGUAGE REGARDING PERSONS WITH DISABILITIES; AND TO AMEND SEC. 48-488. “SPECIAL EXCEPTIONS” FOR DEVELOPMENT PROJECTS ON SITES DESIGNATED AS SPECIAL REVITALIZATION DISTRICT FOR EDUCATION AND ECONOMIC DEVELOPMENT AND DESIGNATED FOR MIXED-USE ON THE FUTURE LAND USE PLAN MAP

**(TO18-07)** ORDINANCE TO AMEND CHAPTER 8, ARTICLE VI, OF THE CODE OF THE CITY OF FALLS CHURCH, “PRIVATE SCHOOLS, SPECIAL SCHOOLS AND HOME CHILD CARE FACILITIES.”

**MOTION to grant first reading to (TO18-07), schedule public hearing and second reading for July 23, 2018, and advertise the same according to law PASSED 6-0.**

**(TR18-34)** RESOLUTION AUTHORIZING THE CITY MANAGER TO EXECUTE THE THIRD AMENDMENT TO THE CAPITAL FUNDING AGREEMENT (CFA) AMONG WASHINGTON METROPOLITAN AREA TRANSIT AUTHORITY (WMATA) AND THE CONTRIBUTING JURISDICTIONS AND TO OPT-OUT OF WMATA’S ISSUANCE OF DEBT CONSISTENT WITH THE CFA
