

# LEGISLATIVE UPDATE

## Actions of the City Council for April 9, 2012

### Legislation

- (1) **Public Hearing Only – No Council Action Will Be Taken (TO12-06)**  
ORDINANCE SETTING THE RATE OF TAX LEVY ON REAL ESTATE, PERSONAL PROPERTY AND MACHINERY AND TOOLS, AND ALLOTHER PROPERTY SEGREGATED BY LAW FOR LOCAL TAXATION IN THE CITY OF FALLS CHURCH, VIRGINIA, FOR THE TAX YEAR 2012. (*Wyatt Shields, City Manager*)
  
- (2) **Public Hearing Only – No Council Action Will Be Taken (TO12-07)** AN ORDINANCE FIXING AND DETERMINING THE BUDGET OF EXPENDITURES AND REVENUES, APPROPRIATING FUNDS FOR THE FISCAL YEAR 2013: GENERAL FUND; SCHOOL OPERATING FUND; SCHOOL COMMUNITY SERVICE FUND; AND SCHOOL FOOD SERVICE FUND; WATER REVENUE FUND AND SEWER REVENUE FUND. (*Wyatt Shields, City Manager*)
  
- (3) **Public Hearing Only – No Council Action Will Be Taken (TO12-08)** AN ORDINANCE FIXING AND DETERMINING THE FY2013-FY2017 CAPITAL IMPROVEMENTS PROGRAM BUDGET AND APPROPRIATING EXPENDITURE AND REVENUE FUNDS FOR THE FISCAL YEAR 2013. (*Wyatt Shields, City Manager*)  
**PUBLIC COMMENT ONLY. NO Council action.**
  
- (4) **(TO12-05)** ORDINANCE TO AMEND CHAPTER 42, “UTILITIES”, TO REVISE SEWER RATES. (*Brenda Creel, Director of Public Utilities*)  
**PASSED on roll call vote, unanimously 7-0. (Ord. 1873)**
  
- (5) MOTION TO AUTHORIZE THE CITY MANAGER TO RELEASE AN INVITATION TO BID ON WATER UTILITY ASSETS, INCLUDING, BUT NOT LIMITED TO, A 40 YEAR EASEMENT FOR ASSETS LOCATED ON THE CITY’S PUBLIC PROPERTY. (*Wyatt Shields, City Manager*)

**MOTION: to Authorize the City Manager to issue an “Invitation to Bid” on the City Water Utility Assets, including, but not limited to, a 40 year easement for**

**Assets located on the City's public property, and release all associated documents to ensure a fair, open, and competitive bidding process.**

**PASSED on roll call vote 6-1; with Mr. Snyder voting NAY.**

(6) **(TO12-09)** ORDINANCE TO AMEND THE BUDGET OF EXPENDITURES AND REVENUES OF THE GENERAL FUND, THE WATER FUND, AND THE CAPITAL IMPROVEMENT FUND TO APPROPRIATE GRANTS, BOND PROCEEDS AND USE OF FUND BALANCE, AND TO APPROPRIATE THE EXPENDITURES AND REVENUES OF THE AFFORDABLE HOUSING FUND FOR FY2012. (*Richard La Condre', Director of Finance*)

**PASSED on roll call vote on first reading, unanimously 7-0; with public hearing and second reading scheduled for April 23, 2012.**
