Actions of the City Council for September 28, 2015

Resolutions and first readings of ordinances

(TO15-11) ORDINANCE TO AMEND CHAPTER 8, ARTICLE VI, OF THE CODE OF THE CITY OF FALLS CHURCH, “PRIVATE SCHOOLS, SPECIAL SCHOOLS AND HOME CHILD CARE FACILITIES.”

MOTION to grant first reading of (TO15-11) and schedule a public hearing and second reading for October 13, 2015, and advertise the same according to law PASSED on roll call vote, 6-0. (Mr. Sze was absent.)

(TR15-23) RESOLUTION TO AUTHORIZE PROJECTS UNDER VDOT’S REVENUE SHARING PROGRAM FOR FY 2017.
