

LEGISLATIVE UPDATE

Actions of the City Council for November 23, 2009

The following legislation was considered and acted upon by the City Council of the City of Falls Church. Copies of legislation are available from the City Clerk, Kathleen Buschow, 703-248-5014.

Legislation

(1) **(TO9-13)** Ordinance To Amend Chapter 8, “Businesses And Business Regulations,” Division 3. “Permits; Compliance Procedures,” Division 4. “Review Of Plans And Specifications,” Division 5. “Youth Athletics Concession Stands,” And Article V. “Water Recreation Facilities,” Division 1. “Generally.”

PASSED on roll call vote, unanimously 7-0. (Ord. 1836)

(2) **(TR9-30)** Resolution Adopting The City Of Falls Church 2010 Legislative Program (Cindy Mester, Assistant City Manager)

PASSED on roll call vote, unanimously 7-0. (Res. 2009-30)

(3) **(TO9-14)** Ordinance To Move Council Election Date ~~From May 2010 To November 2010, And Every Second November Thereafter.~~ (John Foster, City Attorney)

AMENDMENT: Title amended as indicated.

PASSED on first reading on roll call vote 4-3, with Messrs. Baroukh, Snyder, and Webb voting NAY; and with second reading and public hearing scheduled for December 14, 2009.

Other Motions

(TR9-32) Resolution Endorsing A Referendum Initiated By Registered Voters Of The City On Whether City Council Elections Should Be Held In November (Council Member Webb)

- MOTION: Mr. Baroukh MOVED, seconded by Mr. Snyder, approval of TR9-32.

FAILED on roll call vote, 2-4, with Mayor Gardner, Mr. Maller, and Mr. Sze voting NAY, and with Mr. Webb ABSTAINING. (Mayor Gardner noted that those voting against passage of the resolution did so because they preferred to have further discussion at the December 14, 2009 Council Meeting.)

PASSED on roll call vote, unanimously 7-0.
