- (TO9-14) Ordinance To Move Council Election Date  
**MOTION TO POSTPONE passed on roll call vote, 5-0. (Mr. Lippman and Mr. Snyder were absent.)**
- (TO9-15) Ordinance To Move Council Election Date to November 2011  
**PASSED on roll call vote on first reading, 3-2, with Mr. Baroukh and Mr. Webb voting NAY. (Mr. Lippman and Mr. Snyder were absent.)**
- (TO9-16) Ordinance To Move Council Election Date to November 2013  
**PASSED on roll call vote on first reading, 3-2, Mr. Baroukh and Mayor Gardner voting NAY. (Mr. Lippman and Mr. Snyder were absent.)**
- (TR9-32) Resolution Endorsing A Referendum Initiated By Registered Voters of the City on Whether City Council Elections Should be Held in November (Council Member Webb)

- (TR9-35) Resolution Requesting The General Assembly Of Virginia To Amend Section 3.01 Of The City Charter To Hold Council Elections In November 2012 (Mayor Gardner)  
**WITHDRAWN by Mayor Gardner. (Mr. Lippman and Mr. Snyder were absent.)**
- (TR9-37) Resolution Submitting to the Qualified Voters of the City a Referendum on Whether Section 3.01 of the City Charter Should Be Amended to Hold Council Elections in November (Council Member Baroukh)  
**FAILED for lack of a second. (Mr. Lippman and Mr. Snyder were absent.)**
- (TR9-39) Resolution Endorsing Further Study On Whether City Council Elections Should Be Held In November (Council Member Webb)  
**WITHDRAWN by Mr. Webb. (Mr. Lippman and Mr. Snyder were absent.)**
- (TR9-38) Resolution Authorizing December 24, 2009 as a Full Day Holiday for City Employees.

(Mr. Lippman and Mr. Snyder were absent.)**
