Actions of the City Council for May 10, 2010

Legislation

(TO10-09) An Ordinance Fixing And Determining The FY2011- 2015 Capital Improvements Program Budget And Appropriating Expenditure and Revenue Funds For The Fiscal Year 2011

TABLED indefinitely.

(TO10-10) An Ordinance Fixing And Determining The FY2011 Capital Improvements Program Budget And Appropriating Expenditure and Revenue Funds For The Fiscal Year 2011

PASSED on first reading on roll call vote, unanimously 7-0; referred to the Planning Commission for recommendation, with public hearing and second reading scheduled for May 24, 2010.

(TR10-19) Resolution Adopting the FY2012 - 2015 Capital Improvements Program.

PASSED on roll call vote, unanimously 7-0; referred and scheduled for adoption on May 24.

(TR10-17) Resolution Defunding Certain Capital Projects And Transferring \$4,671,732 From The Capital Fund To The General Fund For Fund Balance Restoration.

PASSED on roll call vote, unanimously 7-0. (Res. 2010-15)
