

LEGISLATIVE UPDATE

Actions of the City Council for June 26, 2010

Legislation

(1) **(TO10-12)** ORDINANCE TO AMEND CHAPTER 26, "MOTOR VEHICLES AND TRAFFIC", OF THE CODE OF THE CITY OF FALLS CHURCH, VIRGINIA, BY AMENDING AND REENACTING SECTION 26-19, "USE OF PHOTO-MONITORING SYSTEMS TO ENFORCE TRAFFIC LIGHT SIGNALS; PENALTY"

PASSED on roll call vote, unanimously 7-0. (Ord, 1847)
