Actions of the City Council for November 13, 2018

Call to Order: Mayor Tarter called the meeting to order at 7:32 p.m.

Roll Call: Upon roll call, the following members were present: Mayor Tarter, Mr. Litkenhous, Mr. Sze and Mr. Snyder. Mr. Duncan, Ms. Hardi and Vice Mayor Connelly arrived after roll call.

Second readings of ordinances and other items requiring public hearings – None.

Resolutions and first readings of ordinances
