NA	The RFP contains an educational specification that indicates a 30% core factor for the referenced facilities but as well asks for innovative design concepts. For typical high school core factors the Virginia Department of Education identifies 38% in their 2013 "Guidelines for School Facilities in Virginia's Public Schools" and a planning document from the Council of Educational Facility Planners International (CEFPI) "Creating Connections" identifies 45%, which we believe is a more appropriate range. Following best practices, we request FCCPS increase the core factor to a minimum of 43%.	The reference in the question to the 30% "core factor" for non-programmed space shown in the program of each facility is not a design requirement. The factor is included to provide a rough estimate of building gross square feet. While the specified size of programmed spaces is required, the final building gross square feet and the associated core factor will vary based on a Proposer's design.
NA	The educational specification does not indicate a preference for individual student storage. While school systems grapple with lockers in corridors, lockers in pod areas or no lockers at allwhat is FCCPS' preference?	Provide 12" wide x 15" deep, single tier 5' high standard metal lockers along corridor walls. Provide one locker for each student (1,500). Provide lockers with provisions for charging electronic devices.
NA	During the public information meeting on the Project Falls Church stated that the track does not need to encircle the soccer field. Please confirm this.	The descriptions of outdoor sports facilities in Section 4 of the Scope of Work portion of Appendix C ("Outdoor Sports Facilities") reflect the optimal configuration of compatible uses (soccer/field hockey/running track), but not the only acceptable configuration. Alternative solutions that provide the same number of outdoor sports facilities, and of the same sizes as described in Section 4 of the Scope of
